

## Ready, Set, Go... Call for Data and v22 Changes Complete Q & A

- Q. When will the system be updated for the Call for Data?
  - A. The export can be done now with a custom created population. The Selection screen will be available Friday, February 25th.
- Q. "Quick Review" Slide states v22 for metafile. Is this a typo?
  - A. Yes, this was in error. v21b will be used for this Call for Data.
- Q. Do you have a link that we can use to identify the ACOS hospital ID numbers?
  - A. The CoC no longer makes this list available. The only FIN you must ensure is accurate is your facility(ies).
- Q. What did you say not to do again, or you wouldn't have any cases?
  - A. When you are working on your conversion cases the populations have already been selected. For these cases, you will go directly to the List Pop to create your report and do NOT need to select the population.
- Q. Should database validation be done before selecting the export for NCDB?
  - A. Yes, the database validation and quality check reports should be done prior to doing your NCDB export
- Q. I thought the date was 2004, not 2006, for reference year.
  - A. Per the CoC's Call for Data Website the cases from 2006 through 2020 that are new or updated will need to be submitted.

## Q. Is it the case through 2019 or 2020? There seems to be conflicting information from the CoC.

## **Cases Required to Be Submitted**

NCDB recommends that registries use the registry software's automated case selection, to include the following selection requirements.

- Analytic (Class of Case 00, 10, 11, 12, 13, 14, 20, 21, 22)
- Diagnosed on or after 2006
- All cases meeting the above specifications diagnosed from 2020 PLUS
- All cases meeting the above specifications diagnosed in 2006 through 2019 that were
  added or changed since the Call for Data for 2021. See NCDB Call for Data Schedule for
  2019 through 2022.

The 2022 Call for Data will be March 1-31 2022. The 2022 Call for Data will include all cancer cases diagnosed in 2020 and all analytic cases added or changed since December 1, 2020 for cases diagnosed between 2006 through 2019. Please see our website for specific details.

- A. The second screenshot here is referencing cases updated that were previously submitted that is why it references through 2019. This is because those cases have been previously submitted. Facilities need to submit cases that are diagnosed on/after 2006 through 2020 all new and/or updated cases.
- Q. If my reference year is 2010, do I submit cases back to 2006 or 2010?
  - A. Because your reference year is more recent you will choose your reference year. Your facility would submit all new and updated cases from 2010 to 2020.
- Q. Once the NCDB file is created for submission, that will be the file used from the date forward and not re-created once cleaned and ready for submission?
  - A. No, each time you clean the edits and update your cases you will need to re-create your submission file so that it reflects the updated information added to the abstract.
