
### Cancer & Breast Program Maintenance Screens


Both the Cancer Program Maintenance (CPM) and Breast Program Maintenance (BPM) screens have been updated to be in compliance with the 2020 standards. Many of the existing fields have been updated and new fields have been added. This CRStar Insight will illustrate the changes and provide the field index numbers to be used for reporting, color coding, etc. While the fields on the CPM and BPM screens are not required to be collected, they are extremely valuable for tracking and reporting on program standards and initiatives.

#### Highlights and Overview of Changes (CPM)

- The CPM screen has been divided into two tabs: Continuum of Care Services and Cancer Conferences & Clinical Trials.
- The screen shots on page 2 will indicate new fields with a blue star.
- An auto calculated field was added to calculate the number of days between the date of diagnosis and the date the SCP was generated.
- Several fields have been changed to allow the user to choose more than one value, i.e. refer to support, cancer conference attendees.
- Genetic counseling fields have been added.
- Date QA performed has been added.
- Type of screening was added to the screening fields.
- Synoptic op report fields have been added.
- A user defined text field has been added.
- Many fields have been added to the cancer conference multi valued section to comply with items that should be discussed at cancer conferences.
- A cancer conference discipline field has been added to record the type of each conference.
- All fields have corresponding field index numbers to use in reporting. A table has been provided on pages 3 and 4.



- Genetic Counseling fields have been expanded.
- The ability to add Plastic Surgeon has been added.
- Fertility and pregnancy fields have been added.
- Screening information is now available.
- Additional surgery and lymph node fields have been added.
- Navigation and SCP have been expanded.
- Outside path review has been added.
- Referred to Support has been expanded to be able to choose more than one code.
- Auto calculated fields have been added for multiple fields for Days from .... to certain events
- BPM user defined text has been added.
- All fields have corresponding field index numbers to use in reporting. A table has been provided on pages 6 and 7.
