Enhancements

- The AJCC Version 9 protocols have been added to the right-side panel viewer when on the staging screen (Cervix Uteri, Appendix, Anus, Brain and Spinal Cord, Vulva, NET Stomach, NET Duodenum and Ampulla of Vater, NET Jejunum and Ileum, NET Appendix, NET Colon and Rectum, NET Pancreas)
- The QR code generator was enhanced to ensure consistency with use of two factor authentication
- An enhancement has been made to only allow a System Admin to manually change the "Date Abstracted" or "Abstracted By" fields once they are filled in
- The following states now have the v24 state export available: **AL, AZ, CO, FL, LA, MA, MD, MI, MO, ND, NV, OH, OK, PA, RI, VA, and WV**

Corrections

- Corrections have been made to "Select a Pop" to prevent the user from getting kicked out when blank rows are added to the selection criteria. Also, additional data values are allowed for selection.
- The clock's start and end time for "Select a Pop" has been corrected
- The import process has been corrected to prevent internal errors when a file has a blank MRN that needs padding, apostrophes contained in ICD-10 descriptions within the file, or when adding follow-up to a patient with more than ten primaries
- A correction was made to allow for all selected imported fields to display on the import report if chosen in the import configuration
- A correction has been made to the "Surgery Latest Consolidated Standard" field auto-fills, so that the conversion now calculates the latest equivalent 4-digit codes for report purposes

State Specific Updates

- Arkansas – The state requirement to collect height and weight is now available on a state specific screen
- Florida – The Florida Follow-up Import has been corrected to take the alternate accession number field into account and adjusted for the newer Radiation field in the layout
